IMPORTANT NOTICE

In connection with gaining knowledge by SMARTT Broker Ubezpieczeniowy Sp. z o.o. (the "Company") of emerging cases of websites being posted on the Internet, the content of which indicates that the Company is an operator of a trading platform providing services in the field of trading in foreign currency derivatives, called "SMARTT FX", authorised by the British Financial Conduct Authority ("FCA"). (the "Platform"), the Company hereby explains that:

- 1) The Company has not and has never had anything to do with the Platform, and does not and has not been active in the financial services market to which the Platform relates; the Company operates only as a licensed insurance intermediary authorised to act as an insurance broker ("Brokerage Activitiy"), in accordance with the authorisation granted by the Polish Financial Supervision Authority on 3 April 2017);
- 2) The Company is legally entitled to provide only brokerage services in the United Kingdom (as evidenced by its entry in the relevant FCA financial services register), but currently the Company does not carry on any such activities there nor does it carry on any activities that require authorisation or registration in any jurisdiction other than the Brokerage Activity:
- 3) the activities of the Platform are not registered by FCA, and FCA has posted on its website (https://www.fca.org.uk/news/warnings/smartt-fx-clone-eea-authorised-firm) an appropriate warning indicating the risk of loss to those who choose to use the services of the Platform in circumstances that may indicate the use of the Platform for the purpose of committing an offence against their property:
- 4) The illegal use of Company's data (details regarding Company) in order to substantiate a legal status of the Platform as allegedly operated by the Company (with the relevant FCA authorisation) is the essence of the so-called "cloning", whereby an unidentified entity impersonates the Company by misleading investors using the services of the Platform as to the identity of the company operating the Platform, in order to facilitate the possibility of abusive and criminal behaviour (such as fraud) towards such investors (acting in confidence in the aforementioned authorisation); in such situation, the use of the services of the Platform may result in irreparable damage to their property:
- 5) The Company does not bear any responsibility for the consequences of cooperation with the Platform of persons who have used its services based on information available on the websites offering services of the Platform;
- 6) Company takes appropriate legal steps to protect its legitimate interests that have been compromised by the use of the Company's identity as part of the activities of the Platform, trying to monitor the situation on an ongoing basis, and if a suspect website through which the Platform operates is identified, the Company requests the relevant registrar of the Internet domain to block it (as was the case with the websites at the addresses: https://smartforex.site/, www.smart4ex.com and web.smart4ex.com). Due to the fact that further addresses of websites reproducing the disputed content related to the activities of the Platform may still appear, the Company recommends a far-reaching caution and not using the services offered through these websites.
